CNYHIMA

Onondaga Community College and the Syracuse City School District have partnered for the past few years to train high school students through the Pathway to Early College Education in High School (PTECH) Grant. Students in this program earn college credit for the Health Information Technology AAS degree while completing their high school graduation requirements. In addition to a scholarship of free college tuition and textbook/related materials, students benefit from one-to-one mentoring, career coach sessions and field trips to local health care organizations. The scholarship focuses on students who may not have otherwise had the opportunity to attend college. To be eligible, students must apply during their 8th grade to the PTECH program. The students and their parents participate in several bi-directional interviews to ensure this is a good fit for them and will meet their educational goals.

Currently, students are taking their high school education requirements and filling their electives with HIT focused courses as 9th and 10th grader. Students in the 11th grade are taking their first on-campus course (HIT 101: Introduction to HIT) this semester. At the time the student complete his/her high school coursework, a total of 20 credits will have been completed.

The district is actively recruiting HIM professionals to assist as career coaches and

to host the class on a field trip. The focus of the visit to the classroom is varied and well-supported by the district's faculty. In the past, topics ranged from "Professional Communication does not include text-lingo", "Using a spreadsheet to collect and analyze information", to "Writing a resume". If you have a few hours you are willing to share with our future HIM professionals, we would love to have you join the team. RRHIMA Member Hightlight: Judy Kelly, RHIA, CCS, CCS-P



Judy Kelly is the Senior Director of HIM for Rochester Regional Health, a large integrated health system in Rochester New York. Upon graduation thirty-two years ago from Monroe Community College, she began her career in Health Information Management. Judy first focused her studies in Laboratory Technology but quickly changed to HIM as she realized she did not possess the rigorous math skills that would be necessary to pass the Chemistry courses. After coming upon a

bulletin advertising the HIM program in the colleges hallway she thought perhaps this was the right program for her. "The HIM program was housed in close proximity to where my Lab Tech courses were I started looking at some of the materials the program had posted in study areas and found the descriptions related to many of my areas of interest so I changed my majors and found HIM to be a great career choice!" .She said she just happened to fall into it like so many other HIM professionals that truly never knew too much about the program. She graduated in 1986 and obtained her RHIT credential shortly thereafter. Judy considers herself a lifelong learner and has sought additional degrees that she felt would help continue to further her career. In 2004 she earned a BS in Healthcare Management from Empire State College, followed by a dual Masters in HIM and IT Leadership from the College of St. Scholastica, where she also obtained graduate certificates in Health Information Exchange and Healthcare informatics. She held various positions during her 26-year tenure with Thompson Health in Canandaigua, New York. Her roles included coding, chargemaster and reimbursement, Medial Staff Quality Coordinator, and as the Director of HIM, CDI and Utilization Management. She joined Unity Health System in 2011, and then became part of Rochester Regional Health in 2014, after Unity merged with the former Rochester General Health System.

Capturing Sexual Orientation/Gender Identity Data through HIT Posted By <u>AHIMA Staff</u> on Nov 19, 2018

This blog explores health informatics-a collaborative activity connecting people, process, and technologies to produce trusted data for better decision-making.

It was just over a year ago, at the 2017 AHIMA Annual Convention and Exhibit, that I first attended a session on the disparities that our LGBTQ population faces in healthcare and the issues of capturing sexual orientation/gender identity (SO/GI) information in the electronic health record (EHR). I have a family member and friends who are part of the LGBTQ community, and that presentation ignited my passion to continue to support and bring awareness to these issues in hopes of breaking down pre-conceived ideas, creating a more inclusive environment, and capturing necessary information in the EHR to support these goals and to help with future research and treatment of LGBTQ patients. No matter what your personal or religious beliefs may be, this topic is an issue that needs to be addressed from a medical and a human rights perspective. Capturing SO/GI information will assist in providing more patient-centered treatment/care, encourage staff to provide more culturally-sensitive services to all patients-including those that are LGBTQ, and reduce health disparities through monitoring of the quality of treatment/care to LGBTQ patients.
