2015 ICD-10 PCS AND GEMS UPDATES

While there were no actual ICD-10-CM changes for 2015, they did re-date all the files with 2015. For ICD-10-PCS there were no code changes, however, there are addenda to the index, definitions, new substance key entries, and changes to the reference manual. The 2015 addendum states:

- No new codes were added or deleted for FY2015
- No codes were deleted for FY2015
- No code titles were revised for FY2015

US Department of Justice News

Medical Center to Pay Nearly \$41 Million to Resolve Allegations of False Billing for Unnecessary Cardiac Procedures and Kickbacks

In May Ashland Hospital Corp. d/b/a King's Daughters Medical Center (KDMC) agreed to pay \$40.9 million to resolve allegations that it submitted false claims to the Medicare and Kentucky Medicaid programs for medically unnecessary coronary stents and diagnostic catheterizations and had prohibited financial relationships with physicians referring patients to the hospital.
