# ANTHONY L. JORDAN HEALTH CENTER JOB DESCRIPTION

**JOB TITLE:** LPN-Practice Transformation

**<u>DEPARTMENT:</u>** Nursing – Woodward

**REPORTS TO:** Practice Manager- Woodward

FLSA (TBD by HR): Non-Exempt

**JOB PURPOSE:** The primary role of the Licensed Practical Nurse (LPN) is to work as a member of the primary health care team in a supportive capacity to the Physician and Nurse Practitioner.

## **MAJOR RESPONSIBILITIES (Essential functions):**

Huddle Prep: documenting in the chief complaint of the EMR, reason for last visit, plan from the last visit, review treat section of the EMR and summarize what happened, pull in all pertinent Labs and Diagnostic Imaging, review the Preventive Measures (CDSS) and address accordingly.

Huddle – LPN leads huddle, LPN reports what is needed for patient base on his or her notes, each patient to be discussed in sequence, and discussion should stay on track do not go off on non-patient tangents.

Agenda Setting – LPN shares screen with patient while collecting data from the patient, excreating a list that shall include reason for visit, med reconciliation, allergy verification, vitals, etc.

Debrief Huddle – Team (LPN/Clinician/ and other interdisciplinary team members (SW, RN Care Manager, Behavioral Health, etc), discuss session, how they can work better together, remove any ordered medications for patients who no-showed, rescheduled or cancelled.

Attend and participate in assigned team meeting

Administers medication and performs various procedures, in conjunction with

patients visit, as prescribed by the physician or nurse practitioner.

Provide for patient education to clients.

Orders supplies/Restocks exam rooms supplies

Trained to do Team Documentation/Scribe

Respond to Clinician Jelly beans/computer tasks

Keep NYSIIS up to date

Participate in new Nurse Orientation

Attend nursing meetings, center meetings, clinical trainings and center trainings as directed

Notifies manager when equipment is malfunctioning

Must pass Medication Proficiency test.

Must have current Infection Control training.
